## Competition Law: does it matter to HR?

Human resources practitioners always regard themselves as strategic partner to the business. With the Competition Ordinance (Cap 619) fully enacted on 14 December this year, do they really know how this new law affects the business as well as the HR profession? What do they need to act in order to safeguard the organizations on any possible HR related risks from this new law?

This seminar aims to assist employers to cope with the implementation of the Competition Ordinance. The seminar will provide key concepts which employers should know about the new law. The seminar will cover the following areas:

- The key prohibitions under the Ordinance;
- Powers of the Competition Commission and Competition Tribunal;
- Areas of risks for employers; and
- How HR practitioners may ensure compliance of the new law and minimize risk exposure.
